Mr. [REDACTED]:

Please be advised that Caddo Parish does not have any record responsive to your request. Also please be advised that it is my interpretation that the CJ-9 does not apply to juvenile facilities, as they are not correctional facilities as defined by the Bureau of Justice Statistics. The Bureau defines corrections as those detained for crimes. Juveniles are detained pending adjudications of delinquency as opposed to detained pending conviction. (see link below for BJS definition of corrections):

Additionally, according to the BJS website, collection for deaths in state juvenile correctional facilities was discontinued in 2006. It is my understanding that OJJ still reports deaths in their state facilities, but I am unsure which form they use, because the last juvenile reporting form available is a 2007 form (not a CJ-9).
