

RE: "Basic Jail Guidelines" Monitoring Report

Please see the attached monitoring report regarding the Basic Jail Guidelines (BJG) annual inspection that was conducted at LaSalle Correctional Center on November 17, 2023. The inspection report indicates inmate-on-inmate assaults and seizure findings were above normal during this reporting period. Also, during the walk through of the facility following was noted:

- Several items of clothing and blankets hanging from bed areas. Inmate belongings are not stored properly and all on the floor and bed areas. The plan of action by staff is to have the dorms cleaned up and inmate belongings stored properly.
- Several cells had inmates sleeping on the floor. The plan of action for inmates sleeping on the floor was to have only the number of inmates in a cell according to the number of bunk beds available.
- III-A-001 "Rules and Discipline" - Currently the facility's offender orientation does not include the application process for applying for restoration of good time. Plan of action according to staff - policy is being revised to include the process but inmates are made aware of the process during admissions.
- IV-D-001 "Healthcare Quarterly Meetings" - No record of quarterly healthcare meetings being held at this time. Plan of action - The administrative staff advised they will start having quarterly meetings again with healthcare personnel.

DPS&C would like to encourage full compliance with BJD I-A-004 "Housekeeping", III-A-001 "Rules and Discipline", and IV-D-001 "Healthcare Quarterly Meetings". BJD Team Leader Col. Chad Firmin as well as DPS&C is available should LaSalle Parish Correctional need assistance. At this time DPS&C will return within 60 days from the date of this memo to ensure compliance with the above referenced guidelines and concerns. Thank you for your support of the BJD process.

GENERAL APPEARANCE, CLEANLINESS, AND COMMENTS OF THE FACILITY:

Living Area:

- **Dorms** – Several items of clothing and blankets hanging from bed areas. Inmate belongings not stored properly and all on floor and bed areas. Plan of action by staff is to have the dorms cleaned up and inmate belongings stored properly.
- **Cell Block** - Cell 102 had 1 inmate sleeping on the floor, cell 103 had 2 inmates sleeping on the floor, cell 104 had 1 inmate sleeping on the floor. Styrofoam trays and cups had not been picked up from the previous meal. Plan of action for inmates sleeping on the floor was to have only the number of inmates in a cell according to the number of bunk beds available.

Culinary/Dining: The kitchen area is clean. The inmates do not eat in the dining hall. The meals are brought to the housing units. Utensils are on inventory and being signed in and out. Records of cooler/freezer temperatures are being logged. Record of meals served on file.

Bathrooms: Bathrooms are clean and in working conditions. Adequate hot water available with hot water temperatures being checked daily.

Yard Areas: The yard area is clean. Log book documentation reviewed where inmates have access to the yard for recreation.

Maintenance: The maintenance shop is located behind the facility. Tools are on inventory and in a locked cage area. Tools are signed in and out.

REVIEW AND COMMENT ON THE FOLLOWING BASIC JAIL GUIDELINES: (Compliant or Non-Compliant)

DHH inspection was done on 11-14-23 with the description of violations noted were walls are not smooth and cleanable and peeling paint in the showers. Violations noted in the kitchen area is floor is not maintained in good repair. Corrective action letter stating they are currently preparing to paint the shower walls and plans to completely have the kitchen floor resurfaced. The FM Inspection was done on 1-26-23 with description of violations noted as the fire alarm panel was in trouble. Corrective action on the fire alarm system was the alarm company came out to the facility and made the repairs and been waiting on the FM to return to inspect the system.

STAFF COMMENTS/MORALE/GENERAL OBSERVATIONS:

During the inspection of the facility staff was observed making rounds throughout the facility using their handheld electronic devices to log rounds made by staff. Staff were knowledgeable of duties and were very courteous during the visit. Administrative staff advised there are still no programs or education offered at this time. They only have 22 DOC offenders on the day of the audit. If any DOC offender request any type programs to participate in then they would be sent to a facility that offers such programs. **In the housing unit inmate belongings were not stored properly and clothing, bedding items hanging all off the beds making a curtain. Other personal belongings were all on the floor and under the beds as well. The dorm needed to be cleaned.**

OFFENDER COMMENTS/MORALE/QUALITY OF LIFE:

Spoke to a few DOC inmates during the walk through. There were no concerns or problems voiced by inmates. Inmate quality of life appears good.

RECOMMENDATION:

At this time continued annual monitoring is recommended once the facility is compliant with BJJ IV-D-001 Healthcare Quarterly Meetings (mandatory).

L.R.S. 40:1577 APPEAL FROM ORDER

When an order is made by one of the deputies or representatives of the Fire Marshal, the owner or occupant of the building or premises may, within three days, appeal to the Fire Marshal. The Fire Marshal shall, within five days, review the order and advise the owner or occupant of his decision thereon. The owner or occupant may, within five days after the making of affirming of any such order of the Fire Marshal, file an application with the Board of Review.

RULES FOR APPEALING TO THE FIRE MARSHAL BOARD OF REVIEW

- i. Any application to the Board of Review shall contain the following basic information set off in organized fashion with captions indicating that the paragraph in question contains the following basic information.
 1. The name of the applicant.
 2. A brief description of the facts.
 3. A copy of the order of the Fire Marshal which is being appealed.
 4. A reference to the section of the law or code being reviewed.
 5. A brief description of why the applicant feels the requirements of the Fire Marshal is not within the Fire Marshal's authority, or brief description of why the interpretation of the Fire Marshal is incorrect or what specific relief is required by the applicant.
 6. A list of the individuals who will be appearing before the Board, and a brief description of the testimony or information they will be providing the Board.
 7. A list of all the documents which will be introduced or provided to the Board along with a brief description of the documents, and if possible, a copy of said documents.
 8. A list of each exhibit except for documents, and a brief description of the exhibit.

- ii. Whenever possible, a notice of the meeting, date and place, and the agenda will be recorded in the Louisiana Register, however, whenever that is not possible, a copy of the meeting notice including the date, time and place, and agenda of the meeting of the Board will be published in the official notices of the official state journal; furthermore, a press release containing the same information will be mailed to the official journals of the cities of Shreveport, Monroe, Lafayette, Lake Charles, Alexandria, New Orleans, and Baton Rouge and any city or town in which the meeting of the Board is to be held if it is not one of the aforementioned major cities; and the same information shall be mailed to each individual who has notified the Fire Marshal of his desire to receive a notice of such appeal.

- iii. A copy of the determination of the Board as prepared by the Chairman will be mailed to each individual who requests a copy of that specific determination as well as to the applicant.

- iv. The time delays for filing an appeal shall be those specified in R.S.40:1577 and 40:1578 1 D.



RS 40:31.38 (ACT 66) authorizes the Louisiana Department of Health to charge a fee of \$150 to any permitted facility that fails to correct the necessary sanitary code violations to be in compliance at the time of its follow up inspection (1st re-inspection). Re-inspections are required when there are five or more uncorrected non-critical violations and/or one or more uncorrected critical violations remaining at the conclusion of an inspection. The fee is only charged if the necessary violations are not corrected before the 2nd re-inspection and other subsequent re-inspections. Facilities can avoid this fee if the violations noted on the routine inspection report are corrected by, or during, the follow up inspection. If a fee is assessed, the \$150 fee is payable within 30 days' notice, and failure to pay shall result in revocation of the permit.


